#### 1. Motions approved by email:

a) Support given to a letter from the Anglian Energy Planning Alliance to East Suffolk Council and Suffolk County Council regarding the Sizewell DCO timetable.

#### 2. Planning applications:

- a) DC/20/1150/FUL for the conversion of an old council depot/storage building into a one bedroomed holiday accommodation, with two extra holiday lodges and a new driveway access into the site from Pretty Road land South of Pretty Road, Theberton supported. Cllr. Philip Baskett declared an interest and took no part in the voting.
- b) DC/20/1202/FUL and DC/20/1203/LBC alteration to form third bedroom, internal bathroom and small extension to North The Old Thatched Cottage, Leiston Road, Eastbridge supported.

#### 3. Actions taken:

- a) Request sent to the District Councillors for a grant for £345.87 from their Enabling Communities Budget for the installation and one year of running costs for broadband in Jubilee Hall no response yet.
- b) With the grant received from the Suffolk Coast and Heaths AONB, Cllr. Hilary Ward purchased two nest boxes, two tree nesters, two hedgehog houses, two bat boxes, two bee and bug biomes and three roosting pockets from the RSPB and two little owl nest boxes from the Garden Gift Shop. These will be sited in both playing fields when the lock down restrictions are lifted.
